Submit \$200.00 deposit fee to cover the 3-game guarantee (possible 4 or 5 games), referee and trophies. The deposit fee, registration form, and a copy of the USA Hockey roster **MUST** be submitted by Dec 22, 2016. **NO GATE CHARGE!**

Format—Round Robin—8 teams

Top two teams from each division will play a crossover semi-final game. The two winners from the semi-finals will play in the championship game.

Squirt & Pee Wee will consist of (3) 10 minute stop periods—Semi & Final will be [3] 12 min

Bantam will be (3) 12 minute. **NO TIME OUTS.**

No overtime for tied games in round-robin play. There will be overtime in the event of a tie game at the end of regulation, for the semi-final and final.

GAME RULES

Deciding Factors for Participation in Championship Game:

- 1) Total points each team has accumulated after the three guaranteed games. (2 points for a win, 1 point for a tie, 0 points for a loss)
- 2) In case of a tie in total points after the three games, the following will be used to break the tie:
 - A) The outcome of the game the two tied teams played. Winner advances.
 - B) The difference between goals "for" and goals "against". Maximum goal differential allowed per game is 7.

- C) Most goals scored in the tournament. Highest positive total advances.
- D) The **FIRST** goal scored in the game the two tied teams played. That team advances.

*In the event of a 3-team tie, then only the games played between the tied teams will be used in the preceding formula. If still tied, then all games played in the Round-Robin will be used.

ALL MAHA AND USA HOCKEY RULES APPLY EXCEPT AS FOLLOWS:

- 1) A Championship game that is tied at

the end of regulation time will have **SUDDEN VICTORY OVERTIME**. Overtime periods will be 5-minute run time with a 2-minute rest period prior to the start of overtime. **THE FIRST GOAL SCORED IS THE WINNING GOAL.**

- 2) Protest fee is \$50.00. Referee on-ice decisions are not eligible for protest.
- 3) Penalties-2-minute minor, 5-minute major, 10-minute misconduct. Any game misconduct penalty incurred during the tournament games will result in the player or coach being suspended from the next tournament game.
